Over the last quarter we made voting recomendations at 528 meetings (3,740 resolutions). At 271 meetings we recommended opposing one or more resolutions. We recommended voting with management by exception at 10 meetings and abstaining at zero meetings. We supported management on all resolutions at the remaining 247 meetings.

We made voting recommendations at 528 meetings (3,740 resolutions) over the last quarter.
